### **ADDITIONAL RULES & REGULATIONS**

- Golf Carts and UTV's are prohibited on 5<sup>th</sup> Street. Golf Carts are prohibited on 1<sup>st</sup> Avenue (Yankee Ave) and Vail Ave. (14<sup>th</sup> Ave south of 5<sup>th</sup> ST)
- Carts shall only be operated from sunrise to before sunset. ATV' and UTV's may be operated during prohibited hours to perform snow removal activities. Golf Carts may only operate between March 1<sup>st</sup> and November 30<sup>th</sup>.
- The number of occupants may not exceed the seating capacity recommended by the manufacturer. While operating, any rider must be seated on the seat and no part of the body of any rider will extend beyond the sides of the cart.
- All operators shall observe all state and local traffic regulations.
- No carts shall be operated or parked upon City Sidewalks.
- No cart shall be operated while under the influence of intoxicating liquor, narcotics or habit-forming drugs.
- No person shall operate a cart in a careless, reckless, or negligent manner, endangering the person or property of another or causing injury or damage to the same.
- All carts shall be equipped with a minimum of the following safety features: a slow-moving vehicle sign, a safety flag which the top shall be a minimum of five (5) feet from the ground level and extend two (2) feet above the highest point of the UTV, adequate brakes, and headlamps and tail lights. Golf carts and UTV's require a rearview mirror and UTV's and ATV's must also have mufflers and an adequate exhaust system. UTV's are required to have front and rear turn signals.
- If the Police Chief approves an application and issues a permit, the operator shall display the permit sticker prominently on the left side of the UTV, and in clear view, with no obstructions.
- The permit may be revoked upon finding evidence that the owner or operator has violated the conditions of the permit or has abused the privilege of being a permit holder. ***Permits expire on December 31<sup>st</sup>, regardless of the date of issue.***
